Inova Health System

Commissioners will receive a presentation from the new President and Chief Executive Officer of Inova Health System – Dr. J. Stephen Jones. Inova is the region's leading not-for-profit healthcare system that serves more than 2 million people annually in its five hospitals and multiple ambulatory programs. Inova is one of the region's largest private sector employers and is redeveloping the former Exxon/Mobil campus in Fairfax County. Dr. Jones is also Professor of Urology at the University of Virginia, which is working with Inova to bring undergraduate medical education and research to Fairfax.

Dr. Jones previously served as President of Cleveland Clinic Regional Hospitals and Family Health Centers. He led 11 hospitals and more than 24 large ambulatory centers. The Cleveland Clinic is regarded as one of the leading, best managed health systems in the country.

State of the State Budget

Neal Menkes and Jim Regimbal from the Virginia Municpal League will brief Commissioners on the State of the State budget and what to anticipate in the coming General Assembly session.
